Banking just got easier!

Did you know that as an ElecTel member, you have access to over 5,000 shared branches with locations in all 50 states? Many credit unions nationwide are part of the CO-OP[®] shared branching network of electronically linked branches, giving you, our members, the convenience of making in-person transactions at a location near you.

You can complete most of your regular transactions free of charge at any other CO-OP[®] shared branching location. You'll be able to make deposits, withdrawals and transfers between accounts. You can also make loan payments and purchase **money orders** and travelers' checks.

It's simple! To complete a transaction at a shared branch, all you'll need to provide is a valid, government-issued photo ID and your account number.

To find a shared branch, check out the CO-OP[®] Shared Branch locator **co-opcreditunions.org/locator/**, or download the CO-OP[®] ATM Shared Branch Locator app and find nearby branches on the go!




Approximately Half of Credit Union Members have access to this network
